Upon submitting your professional registration form and paying your fee, you grant CTI consent to handle your personal information in accordance with the Data Protection Act. About CTI Professional Membership Support Services

At the Complex Trauma Institute (CTI), we are dedicated to empowering professionals who work with traumatised individuals. Our approach integrates somatic, neurobiological, systemic, and community-based methods to promote recovery within relationships and communities.

We believe in practising what we preach. Our goal is to create a professional community where you feel safe, valued, and supported. Just as trauma survivors need communities to recover, professionals like you deserve a space to connect and grow. By fostering cross-disciplinary collaboration, we aim to make a meaningful difference in trauma recovery work.

Eligibility for CTI Professional Membership Support Services

CTI Professional Membership services are not a replacement for the professional bodies that regulate you. Instead, we provide support services and build bridges across disciplines, ensuring that both trauma survivors and professionals' benefit.

Professional Membership is open to qualified professionals and trainees in fields supporting traumatised clients, including: *Psychotherapists, Psychologists, Counsellors, and Social Workers, Complementary Therapists and Occupational Therapists, Social Workers and Physical Health Professionals, Educators, Legal Professionals, First Responders, Humanitarian Workers, Coaches, and many others*

CTI Professional Membership Support Service Benefits

Once you accurately complete our professional registration form and pay your membership fee, you immediately gain access to online CTI Membership Support services. This allows you to select and benefit from the services that best suit your personal and professional growth in the field of complex trauma.

Please note: Access to our services may be revoked if you provide inaccurate information or mislead us during registration.

Benefits may include:

- Access to a **members-only area** featuring resources, e-learning materials, a library, past conferences, a forum, and our journal.
- Regular newsletters with updates on events, training opportunities, and other resources.
- Invitations to free **CPD webinars**, free group learning supervision, and networking events.
- Discounted access to **CPD workshops** (online and in-person), individual supervision, and consultations.
- Conditional inclusion in the **CTI Professional Directory** (this requires meeting specific criteria to be recommended to the public through our Trauma-Informed Directory).

Note: The level of benefits and support may vary depending on the membership package you choose (and is subject to demand).

Participation in CTI Professional Membership Support Services

Participation is entirely your choice:

- If you decide to access resources, please be aware that most are designed to foster personal and professional growth. Whether you are learning trauma-specific therapies or are already an experienced trauma professional supporting clients in crisis, our platform provides the tools you need.
- If you do not need support, your membership fee will contribute to building a community where others can find the support they need. It will also help promote somatic trauma therapies (known as 4th Wave/Generation) and advance the development of community-centred approaches (5th Wave/Generation) through our conferences, training, group supervision, research, journal, and multidisciplinary collaboration.

CTI Professional Members' Responsibilities

By applying for CTI Professional Membership, you agree to:

- 1. Provide accurate and up-to-date personal and professional details that clearly demonstrate you are in training or are already a practising professional working with traumatised clients.
- 2. Abide by the ethical standards of your professional association (e.g., BPS, UKCP, BACP, NCS, or any other relevant body).
- 3. Comply with the terms and conditions outlined in this document.

Cooling Off Period

We offer a seven-working day 'cooling off period' for a new member, effective from the day you paid. This will allow you to cancel your membership with no additional penalties. If you wish to cancel your new CTI membership, you must notify us within these seven working days via e-mail.

Cancellations and Refunds

No refunds will be provided after the seven-working day 'cooling off' period as detailed above.

CTI Membership support service Renewal

<u>Your CTI Annual Yearly Membership</u> will automatically renew. You will receive a renewal notice in advance of the anniversary of your application date, informing you of your entitlement to renew your membership or you can cancel your automatic renewal payments from your "My Subscriptions" page.

Monthly Yearly Membership is a for a minimum period of 12 months from the membership start date. Once you have completed the 12 monthly Direct Debit payments you can cancel your automatic renewal payments from your "My Subscriptions" page.

Queries Comments and Complaints

We will try to respond to any complaint or query received within seven working days. This may be an acknowledgement that we have received a complaint whilst further investigations are being carried out.

Price Information

We reserve the right to increase the price of the membership subscription on an annual basis. You will be informed of any fee increase within your renewal letter. If we discover an error in the price of your membership subscription, we will inform you as soon as is reasonably possible.

Credit/Debit Card Payment

If you are not using your own credit/debit card to pay for the membership subscription, you must ask the permission of the credit/debit cardholder before entering the payment details. When subscribing to CTI either online or verbally, you are confirming that you have obtained prior permission from the credit/debit cardholder.

Liability

Our liability to you will not extend to any association related benefits, goods or services provided by an external provider. We specifically exclude liability for any loss or damage suffered by you as a result of your involvement in whatever manner with an external provider.

Your privacy is very important to us so we're committed to protecting your personal information and handling it in a responsible manner. Personal data

The term personal data is defined as any information that you give us from which you can be identified (including your name, address, email address, or your telephone number). Information where your identity has been removed (anonymous data) is not personal data.

Complex Trauma Institute (CTI) is the Data Controller and Data Processor of any personal data you supply. The personal data you supply will be used to process your association subscription. Your personal data will be processed by CTI administrators who have a duty to maintain confidentiality when processing information. This obligation continues to apply even after their employment with CTI comes to an end.

We use our website provider 'Wix' as a data management system. This system enables us to efficiently store any information about CTI associates in a way that ensures adequate security and only allows people who have the right level of authority to access personal information.

As an associate of CTI your data will be used for marketing, statistical and analytical purposes and to administer your association. You will receive association communications and from time to time we will let you know about CTI promotions.

Data protection via the website

We will make every effort to ensure that the information on our website and within the network is accurate. However, we cannot guarantee this and accept no liability for any information given via this website or network.

Even if data encryption is used, the security of information transmitted via the internet cannot be guaranteed. Any losses incurred or sustained by users who transmit information by electronic means shall be borne solely and exclusively by such user and in no event shall any such losses in whole or in part be borne by us.

CTI Members search facility and 'Members Profile'

Once you become a CTI member and have access to the membership network, you will be able to communicate with other members and share information on platforms such as our forums. You will be able to 'Log in' and create a personal 'Profile' in the Membership area. The information displayed in your 'Profile' (i.e. name, occupation, organisation, profile photograph) is controlled by you. The responsibility of the information and personal data that you share as an associate is held by yourself and CTI will not be liable for this information. You will abide by our code of conduct and confidentiality. Failure to adhere to our 'Terms and Conditions' may result in a disciplinary procedure or removal of CTI membership.

Third Parties

During your association with CTI, we will tell you how your information is used and that it may be necessary to share it with other services and organisations. We may share your personal data only when necessary and in the below cases:

We may also need to share your data:

- Payments. When you make a payment to us, we use a third party processor to manage the process and the direct debit payments.
- With our professional advisers, for example, our accountants or lawyers.
- IT companies that provide our platforms for managing our website, databases, emails, files and forums.
- if we are under a legal duty, for example, if we are ordered by a court to share information, or if we need to share information for the purposes of prevention of fraud or other crime
- where we need to share your personal information with a regulator, for example, making returns to HMRC

Deleting and disposing of your personal data

If you decide to terminate your memebrship with CTI, we will be holding your data until CTI is dissolved as an organisation. If you wish for us to delete your data from our system immediately, please contact info@complextraumainstitute.org

Your rights

You have the right to:

- Request access to your personal information (commonly known as a 'subject access request'). This enables you to receive a copy of the personal information we hold about you and to check that we are processing it lawfully. If you wish to obtain a copy of your personal data held by us, please do not hesitate to email. Please note that you may be charged a fee of £10 for this service. You may also be asked to provide proof of your identity and for information that might help to locate the data you are seeking.
- Correct the personal data that we hold about you if it is incorrect, incomplete or inaccurate.
- Ask to withdraw your consent for CTI to hold and use your data. Please note that if you ask to withdraw your consent, you may not be able to access certain CTI services as we need certain information to send you updates, inform you and/or ensure that you are a qualified professional.
